#### CS/CS/HB 903 (3R) by the Committees on Judiciary Committee, Criminal Justice Subcommittee, Representative Jacques and others—

Corrections; Revises provisions relating to deferral of prepayment of court costs & fees for indigent prisoners for actions involving challenges to prison disciplinary reports; provides for one-year limitation of actions period for certain actions concerning condition of confinement of prisoners; requires exhaustion of administrative remedies before certain actions concerning confinement of prisoners may be brought; provides for dismissal of certain actions involving prisoner confinement; requires showing of physical injury as condition precedent for bringing certain actions relating to prisoner confinement; provides that prison terms for certain offenses committed in conjunction with another felony offense may be sentenced to be served consecutively; revises provisions concerning methods of execution of death sentences; exempts persons working for or at confinement center from provisions regulating use of drones; revises provisions relating to mental health treatment for inmates. Effective Date: 07/01/2025

#### CS/SB 80 (SO) by the Committee on Environment and Natural Resources, Senator Harrell and others—

State Land Management; Citing this act as the "State Park Preservation Act"; requiring public hearings for all updated conservation and nonconservation land management plans; requiring the Division of Recreation and Parks of the Department of Environmental Protection to comply with specified provisions when granting certain privileges, leases, concessions, and permits; requiring that individual management plans for parcels located within state parks be developed and updated with input from an advisory group, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Environment and Natural Resources; the Appropriations Committee on Agriculture, Environment, and General Government reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/CS/HB 209(HC) in the Committee on Fiscal Policy

#### SB 200 (SO) by Senator Berman-

**Comprehensive Waste Reduction and Recycling Plan;** Requiring the Department of Environmental Protection to develop a comprehensive waste reduction and recycling plan for this state by a specified date, based on certain department recommendations; requiring the department to create and convene a technical assistance group for a specified purpose; requiring the department to submit a report to the Legislature upon completion of the comprehensive plan, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Environment and Natural Resources; reported favorably by the Appropriations Committee on Agriculture, Environment, and General Government; and reported favorably by the Committee on Fiscal Policy

Identical to HB 295(HC) in the Committee on Fiscal Policy

#### CS/CS/SB 492 (SO) by the Committee on Rules, the Appropriations Committee on Agriculture, Environment, and General Government and Senator McClain—

Land Development; Beginning on a specified date, revising the schedule for credit release upon issuance of a mitigation bank credit permit; authorizing a mitigation bank applicant to propose an alternative credit release schedule; prohibiting mitigation credits from being released for freshwater wetland creation until certain conditions are met; requiring the department and water management districts to apply proximity factor multipliers in a specified manner; limiting the timeframe for the permit applicant to rely on a credit availability determination for specified purposes, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Environment and Natural Resources; reported favorably as a committee substitute by the Appropriations Committee on Agriculture, Environment, and General Government; and reported favorably as a committee substitute by the Committee on Rules

# CS/SB 494 (SO) by the Committee on Criminal Justice, Senator Leek and others—

Aggravated Animal Cruelty; Citing this act as "Dexter's Law"; requiring the Department of Law Enforcement to post on its website the names of certain individuals who have violated specified animal cruelty provisions; providing a sentencing multiplier for specified offenses of aggravated animal cruelty, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Criminal Justice; the Appropriations Committee on Criminal and Civil Justice reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/HB 255(HC) in the Committee on Fiscal Policy

#### CS/CS/SB 500 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Criminal and Civil Justice, Senator Avila and others—

**Spectrum Alert**; Requiring the Department of Law Enforcement, in cooperation with the Department of Transportation, the Department of Highway Safety and Motor Vehicles, the Department of the Lottery, and local law enforcement agencies, to establish and implement the Spectrum Alert by a specified date; requiring the department, in cooperation with specified entities, to develop a training program and alert system for missing children with autism spectrum disorder which is compatible with existing alert systems by a certain date, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Fiscal Policy

Similar to **HB 711(HC)** in the Committee on Fiscal Policy

# CS/SB 524 (SO) by the Appropriations Committee on Health and Human Services and Senator Harrell—

**Newborn Screenings**; Subject to legislative appropriation and beginning on a specified date, requiring that the Department of Health's rules require that newborns be screened for Duchenne muscular dystrophy at the appropriate age, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Health Policy; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to **CS/CS/HB 1089(HC)** in the Committee on Fiscal Policy

#### CS/CS/SB 592 (SO) by the Committees on Regulated Industries, Banking and Insurance, Senator Leek and others—

**My Safe Florida Condominium Pilot Program;** Limiting participation in the My Safe Florida Condominium Pilot Program to certain structures or buildings; revising the improvements for which a grant may be used; requiring that improvements be verified during the final hurricane mitigation inspection to qualify for grant funds; specifying that mitigation grants may be awarded only for mitigation improvements that will result in a mitigation credit, discount, or other rate differential, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Banking and Insurance; reported favorably as a committee substitute by the Committee on Regulated Industries; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to **CS/CS/HB 393(HC)** in the Committee on Fiscal Policy

# CS/SB 716 (SO) by the Committee on Criminal Justice and Senator Martin—

Sexual Offenses by Persons Previously Convicted of Sexual Offenses; Providing mandatory minimum terms of imprisonment for specified sexual offenses when committed by registered sexual offenders or sexual predators; providing requirements for such sentences, etc. Effective Date: 10/01/2025

Reported favorably as a committee substitute by the Committee on Criminal Justice; the Appropriations Committee on Criminal and Civil Justice reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/CS/HB 1455(HC) in the Committee on Fiscal Policy

#### CS/SB 742 (SO) by the Committee on Education Pre-K - 12 and Senator Simon—

**Workforce Education;** Providing that charter schools are eligible for the Workforce Development Capitalization Incentive Grant Program; revising the number of programs school districts and Florida College System institutions must offer money-back guarantees for through the money-back guarantee program by a specified date; requiring school districts and Florida College System institutions to report such programs to the State Board of Education, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Education Pre-K - 12; the Appropriations Committee on Higher Education reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

Identical to **CS/HB 1145(HC)** in the Committee on Fiscal Policy

#### SB 776 (SO) by Senator Ingoglia-

**Aggravating Factors for Capital Felonies;** Adding as an aggravating factor that the capital felony was committed against the head of a state, or in an attempt to commit such crime a capital felony was committed against another individual, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Criminal Justice; reported favorably by the Appropriations Committee on Criminal and Civil Justice; and reported favorably by the Committee on Fiscal Policy

Identical to HB 653(HC) in the Committee on Fiscal Policy

#### CS/CS/SB 822 (SO) by the Committees on Rules, Education Pre-K - 12 and Senator Rodriguez—

Education; Providing that a lab school may use the lab school's discretionary capital improvement funds for specified purposes; authorizing a charter school governing board to adopt its own code of student conduct; authorizing a charter school to increase its student enrollment beyond the capacity identified in the charter under certain conditions; requiring the Department of Education to provide student performance data to a charter school and its contractor; authorizing a high-performing charter school to assume the charter of an existing charter school within the same school district, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Education Pre-K - 12; the Appropriations Committee on Pre-K - 12 Education reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules

Compare to CS/CS/HB 443(HC) in the Committee on Rules

#### SB 936 (SO) by Senator Davis—

**Statewide Study on Automation and Workforce Impact;** Requiring the Bureau of Workforce Statistics and Economic Research of the Department of Commerce to study the economic impact of automation, artificial intelligence, and robotics on employment in the state; authorizing the bureau to consult with specified entities to complete the study; requiring the bureau to submit to the Governor and Legislature a report by a specified date, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Commerce and Tourism; reported favorably by the Appropriations Committee on Transportation, Tourism, and Economic Development; and reported favorably by the Committee on Fiscal Policy

Identical to HB 827(HC) in the Committee on Fiscal Policy

### CS/SB 964 (SO) by the Appropriations Committee on Criminal and Civil Justice and Senator Bernard—

**Parole;** Requiring the Florida Commission on Offender Review to provide a specified statistical analysis to the Legislature; requiring the Department of Corrections to provide specified information to the commission; requiring the commission to review specified information in certain circumstances, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to **CS/CS/HB 181(HC)** in the Committee on Fiscal Policy

#### CS/SB 976 (SO) by the Committee on Children, Families, and Elder Affairs and Senator Bernard—

**Court-appointed Psychologists**; Requiring a party to seek disqualification of a court-appointed psychologist before filing an administrative complaint against the psychologist; providing for disqualification motions; revising provisions for award of costs and attorney fees in supplemental actions against court-appointed psychologists, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

Identical to CS/HB 901(HC) in the Committee on Fiscal Policy

# CS/SB 1084 (SO) by the Committee on Criminal Justice and Senator Martin—

**Sexual Cyberharassment;** Providing criminal penalties for persons who sexually cyberharass other persons with specified intent or purpose; authorizing an aggrieved person to initiate a civil action to recover punitive damages; providing time limitations for commencing prosecution for violations of sexual cyberharassment, etc. Effective Date: 10/01/2025

Reported favorably as a committee substitute by the Committee on Criminal Justice; the Appropriations Committee on Criminal and Civil Justice reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to **CS/CS/HB 1451(HC)** in the Committee on Fiscal Policy

# CS/CS/SB 1156 (SO) by the Committees on Fiscal Policy, Health Policy and Senator Harrell—

Home Health Aide for Medically Fragile Children Program; Providing requirements for the annual assessment of the home health aide for medically fragile children program; revising the utilization cap of a Medicaid fee schedule; requiring a home health aide for medically fragile children who works more than 40 hours per week to provide specified justification; requiring the agency to seek federal approval and implement federal waivers and state plan amendments for specified purposes, etc. Effective Date: Upon becoming a law

Reported favorably as a committee substitute by the Committee on Health Policy; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy

#### CS/CS/CS/SB 1240 (SO) by the Committee on Rules, the Appropriations Committee on Health and Human Services, the Committee on Children, Families, and Elder Affairs and Senator Calatayud—

Substance Abuse and Mental Health Care; Expanding mental health crisis services to include the 988 suicide and crisis lifeline call center; authorizing the guardian advocate to be discharged when a patient is discharged from involuntary outpatient services; providing that a designated facility that has received the transfer of a patient outside a specified timeframe or that does not receive timely notification of a transfer may not release such patient or be ordered by a court to release such patient under specified circumstances; providing that orders entered by administrative law judges for continued involuntary placement for patients at certain mental health facilities are final and subject to judicial review, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Rules

Similar to CS/CS/HB 1091(HC) in the Committee on Rules

#### CS/CS/SB 1252 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Criminal and Civil Justice and Senator Yarborough—

#### Feasibility Study Relating to a Statewide Pawn Data Database; Requiring the Department of Law Enforcement to conduct a feasibility study regarding the creation of a statewide pawn data database; specifying requirements for such database, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Commerce and Tourism; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Fiscal Policy

Similar to CS/CS/HB 1359(HC) in the Committee on Fiscal Policy

#### SB 1268 (SO) by Senator Simon-

**Department of Law Enforcement;** Repealing provisions relating to the Florida Violent Crime and Drug Control Council and the Violent Crime Investigative Emergency and Drug Control Strategy Implementation Account, respectively; revising the membership of the Domestic Security Oversight Council; including the Governor's mansion in the definition of the term "Capitol Complex" for specified provisions; increasing the maximum annual amount that may be spent for veterinary care of retired police dogs under a program administered through the department, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Criminal Justice; reported favorably by the Appropriations Committee on Criminal and Civil Justice; and reported favorably by the Committee on Fiscal Policy

Similar to CS/CS/HB 1053(HC) in the Committee on Rules

#### CS/CS/CS/SB 1348 (SO) by the Committee on Appropriations, the Appropriations Committee on Transportation, Tourism, and Economic Development, the Committee on Transportation and Senator Trumbull—

**Department of Highway Safety and Motor Vehicles;** Revising penalties for the use of a wireless communications device while operating a motor vehicle; prohibiting a person from selling or offering to sell certain service appointments without the written authorization of the department or a tax collector; authorizing tax collectors to deliver by mail or make available at the tax collector's office certificates of title; revising the year by which the Legislature intends that the transition of certain services to certain tax collectors be completed, etc. Effective Date: 07/01/2026

Reported favorably as a committee substitute by the Committee on Transportation; reported favorably as a committee substitute by the Appropriations Committee on Transportation, Tourism, and Economic Development; and reported favorably as a committee substitute by the Committee on Appropriations

Similar to CS/CS/HB 961, 1st Eng.(HC) in the Committee on Appropriations

#### CS/SB 1354 (SO) by the Committee on Children, Families, and Elder Affairs and Senator Trumbull—

**Behavioral Health Managing Entities;** Requiring the Department of Children and Families to contract biennially for specified functions; requiring the department to contract for recommendations for certain transparency improvements; requiring the department to prepare and present to the Governor and Legislature a specified final report by a specified date; requiring managing entities to report required data to the department in a standardized electronic format, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/CS/HB 633(HC) in the Committee on Fiscal Policy

# CS/SB 1382 (SO) by the Appropriations Committee on Pre-K - 12 Education and Senator Calatayud—

Access to School Readiness Programs for Economically Disadvantaged Households; Revising the Department of Education's

duties for adopting specific program support services to coordinate a comprehensive early learning program; revising duties of early learning coalitions relating to the creation of a uniform waiting list; revising requirements for the school readiness program plan, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Education Pre-K - 12; reported favorably as a committee substitute by the Appropriations Committee on Pre-K - 12 Education; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/CS/HB 859(HC) in the Committee on Rules

#### CS/CS/CS/SB 1444 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Criminal and Civil Justice, the Committee on Criminal Justice and Senator Collins—

**Public Safety**; Authorizing first responder amputees to continue to serve as first responders under certain circumstances; prohibiting the use of motor vehicle kill switches; providing that specified persons may carry concealed firearms under certain circumstances and use them in the same manner as on-duty law enforcement officers; prohibiting a person from depriving specified officers of digital recording devices or restraint devices, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Fiscal Policy

Similar to CS/CS/CS/HB 1371, 1st Eng.(HC) in Messages

#### CS/CS/HB 481 (SO) by the Committees on State Affairs Committee, Natural Resources & Disasters Subcommittee, Representative Lopez, V. and others—

Anchoring Limitation Areas; Restricts local regulation of vessels outside marked boundaries of mooring fields in certain counties; designates specified sections of Biscayne Bay in Miami-Dade County as grandfathered-in anchoring limitation areas; increases prohibited anchoring & mooring distance of vessels & floating structures near public mooring fields. Effective Date: Upon becoming a law

Reported favorably by the Committee on Rules

#### CS/CS/HB 1133 (SO) by the Committees on Criminal Justice Subcommittee, Natural Resources & Disasters Subcommittee and Representative Shoaf—

**Fish and Wildlife Conservation Commission;** Provides for regional representation on FWCC; revises membership & terms; authorizes commission to define geographic boundaries of regions; specifies conditions under which commission officers & personnel may enter private property. Effective Date: 07/01/2025

Reported favorably by the Committee on Appropriations

#### CS/SB 10 (SO) by the Committee on Judiciary and Senator Pizzo—

**Relief of Sidney Holmes by the State of Florida;** Providing for the relief of Sidney Holmes; providing an appropriation to compensate Mr. Holmes for being wrongfully incarcerated for 34 years; directing the Chief Financial Officer to draw a warrant payable directly to Mr. Holmes; providing for the waiver of certain tuition and fees for Mr. Holmes; prohibiting funds awarded under the act to Mr. Holmes from being used or paid for attorney or lobbying fees, etc. Effective Date: Upon becoming a law

Recommended favorably by the Special Master on Claim Bills; reported favorably as a committee substitute by the Committee on Judiciary; the Appropriations Committee on Criminal and Civil Justice reports the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably

# CS/SB 26 (SO) by the Committee on Judiciary and Senator Gruters—

Relief of Kristen and Lia McIntosh by the Department of Agriculture and Consumer Services; Providing for the relief of Kristen and Lia McIntosh; providing an appropriation to compensate Kristen and Lia McIntosh for injuries and damages sustained as a result of the negligence of an employee of the Department of Agriculture and Consumer Services; providing a limitation on the payment of compensation and attorney fees, etc. Effective Date: Upon becoming a law

Recommended favorably by the Special Master on Claim Bills; reported favorably as a committee substitute by the Committee on Judiciary; the Appropriations Committee on Agriculture, Environment, and General Government reports the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably

#### CS/CS/SB 1822 (SO) by the Committees on Rules, Community Affairs and Senator Martin—
